

**Secretarial Compliance Report of Nagpur Power Industries Limited for the financial year  
ended 31<sup>st</sup> March, 2024**

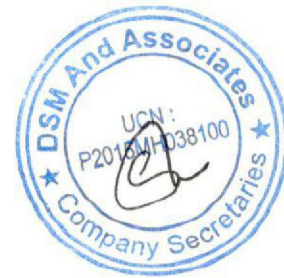

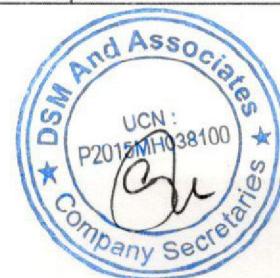
